## SCHOOL ATTENDANCE

We believe that in order for a pupil to fully benefit from their education, good attendance is crucial. It is the policy of our school to celebrate achievement and full attendance is a critical factor to a productive and successful school career.

In September 2013, an amendment to the Education (Pupil Registration)(England) Regulations 2006 came into force and greater clarity was introduced to the issue of schools authorising absence requests. In addition, on 19<sup>th</sup> August 2024, an amendment to the Education (Penalty Notices)(England)(Amendment) Regulations 2024 came into force and set out a new National Framework for issuing penalty notices. These changes reinforced the Government's view that every minute of every school day is vital and that pupils should only be granted authorised absences by the school in 'exceptional circumstances'.

A family holiday is not normally considered by the Government to be an 'exceptional circumstance' and therefore will not be authorised by this school. I must take this opportunity to remind you, that should you choose to take your child out of school without the authorisation of the school, then Parental Responsibility Measures could be instigated. This could mean receiving any of the following:

- A Penalty Notice
- A summons to the Magistrate Court which could result in a fine of up to £2,500 and/or a term of imprisonment for up to 3 months.

Schools are required to notify the Local Authority if a pupil has a number of unauthorised absences. Unauthorised absences can be acquired when:

- 1) Leave has been requested, but the circumstances are such that the school is unable to authorise the leave and it is taken anyway.
- 2) Leave is not requested and/or the school has grounds to believe that the child has been taken out of school for an avoidable reason (example – a family holiday). Only the Head teacher can authorise an absence. This year there have been occasions when schools have been notified that the pupil is sick, but the school later discovers and reasonably believes that the reason given for the absence is not genuine.
- 3) A child continually arrives late after the registration period has closed.

The Exe Valley and Moorsway Federation schools will be notifying the Local Authority in all of the circumstances listed above.

Should a Penalty Notice be issued as a result of unauthorised absence then one notice will be issued to each parent/carer for each child involved. In addition to natural parents and any person with parental responsibility, any person considered to have day-to-day care and control of a young person is deemed to be a parent in matters relating to education and school non-attendance (s576 Education Act 1996).

From 19<sup>th</sup> August 2024, following changes to secondary legislation, the amount charged in a penalty notice was increased. The first penalty notice issued will be charged at £160 if paid within 28 days. This is reduced to £80 if paid within 21 days.

The second penalty notice issued will be charged at a flat rate of £160 if paid within 28 days. If a Penalty Notice goes unpaid after 28 days, then court proceedings will be initiated.

Please make use of these weekends rather than risk having an unauthorised absence and a Penalty Notice or summons.
